FROM THE BOARD OF TRUSTEES

At the March 24, 2011 Annual Meeting, the following bylaw changes regarding membership were approved:

Article III, Membership

An individual 18 years of age or older shall become a member of LBP, Inc. by paying annual dues and volunteering for service to LBP. The amount of dues and the minimum number of hours of volunteer service shall be determined by the Board of Trustees prior to January 31st of each year.

Individual membership with voting rights shall have a term of one year starting August 1st and continuing through July 31st of each year. Voting members must pay their dues and complete their volunteer hours prior to July 31st each year to remain current.

Members are encouraged to attend all membership meetings of LBP, Inc. They have the right to vote, appropriately present opinions, and openly discuss agenda topics.

Members are welcome to attend all regular and special Trustees' Meetings and present opinions as the agenda permits.

The Board reserves the right to meet in executive session to discuss sensitive issues as they may determine. Executive session is open only to Board members and invited participants. All votes will be taken in regular Trustee Meetings.

No adult shall be denied membership based upon age, race, creed, color, national origin, sexual orientation, gender, disability, genetic predisposition, or marital status.

Supporters of LBP who wish to contribute, but may not be able to actively volunteer, may become PATRONS of the playhouse. Making an annual contribution equal to or greater than the amount of annual dues shall entitle PATRONS to all membership rights except the right to vote.

Volunteers are encouraged, but not required, to become members of LBP.

IMPORTANT MEETING DATES

Changes in meeting dates/times will be posted on the website and sent by email to members, who have an active email address with the playhouse.

At the May 22, 2011 board meeting, the Board of Trustees for Lemon Bay Playhouse voted on and passed the following clarification of the *new membership requirements*, effective 6/10/2011.

A. GENERAL

1. Membership Requirements

Annual dues for an individual membership in Lemon Bay Playhouse shall be \$15 for a Contributing Membership. Individuals who pay their dues and give 20 hours of volunteer service in addition will earn a Voting Membership. Family memberships no longer exist after the 2011 Annual Meeting (3-24). Only members who have met the Membership Requirements as a Voting Member are entitled to vote at the Annual meeting.

2. Membership Year

The Membership Year will begin August 1 and terminate July 31 each year. Accumulation of volunteer hours will be from the previous membership year.

3. Annual Reports

All reports will be made available at LBP for review by Members a minimum of seven (7) days prior to the Annual Meeting to be held in the third week of March.

4. Member Decorum and Input to Board Meetings

Members are welcome at all Trustee meetings except Executive Sessions and may speak to any item on the agenda when recognized by the President and may speak for no more than two (2) minutes. Robert's Rules for decorum at board meetings will guide the deliberations.

2011-2012 Season (Transitional Year)

Contribution Levels remain unchanged

Hours are accumulated Jan 1, 2011 – Jan 1, 2012. Existing members with no volunteer hours will have no voting rights.

Memberships paid prior to Jan 1, 2011 will expire on their original expiration date

Memberships after Jan 1, 2011 will be 'grandfathered' and expire on July 31, 2012 but will require 20 volunteer hours between Jan 1, 2011 – Jan 1,2012 to have voting rights. (Family memberships will require *each* person to accumulate 20 volunteer hours to have individual voting rights or will receive one ballot per Family memberships)

Membership can be paid anytime during the cycle – it would be the full rate for that level and expire 7/31/12 (no proration)

2012-2013 Season (begins Aug. 1, 2012)

Contribution Levels remain unchanged

Membership volunteer hours accumulate August 1, 2011 – July 31, 2012

Based on the above, when they pay a minimum of \$15 for each membership they would

Be a member

Be a member with voting rights if they have accumulate 20 volunteer hours

Membership can be paid anytime during the cycle – it would be the full rate for that level and expire 7/31/13 (no proration)
